As an all-volunteer fellowship, we rely on member support in the form of time, talent, and financial contributions.

What is the Process?

- We ask members and supporters to pledge their support for the coming fiscal year (begins June 1,). The board treats these pledges as advisory statements.
- In May, the board develops a budget for the next fiscal year based on pledges received.
- At the annual meeting (May/June), the membership elects a new board of directors and adopts a budget. The approved budget is used to guide expenditures throughout the year.

What does it cost to keep Pilgrim House running?

- Our 2020-2021 budget was \$47,340. We planned \$16,900 for building and grounds, including repairs, utilities, plowing/mowing, cleaning, etc., and \$8,100 for the capital improvement savings account. The remainder was divided among adult programs & speakers, children's programs, social action, and UUA dues & conferences.
- A major expense in 2020 was the partial roof reshingle before installing our solar panels. A major expense planned for 2021 is repair of the driveway and parking lot.

Additionally, we fund a capital improvement savings account for future replacements of furnaces, kitchen

appliances, siding & roofing, and for parking lot and general building maintenance.

SHOULD PILGRIM HOUSE "PILGRIMS" CONSIDER A NAME CHANGE?

During the Sunday, Mar 21, chat after the program, Bill Rohde mentioned the Star Tribune article, "Churches search souls over names." It explains how the "Colonial Church of Edina" and its connotation to "pilgrims" and the "Mayflower Church" think the names carry too much negative baggage and they are considering a name change. Bob Treumann suggested PH consider a name change.

I agree PH should consider a name change. With full respect for the founders, they could not have foreseen the now somewhat negative perception of the word "Pilgrim." Visitors used to come to PH with their bibles looking for a conservative religion, presumably because of the word "Pilgrim." They often left after 10 minutes. I think the group should consider a name change and begin discussion. Here are some key questions:

- * How many current members and friends would leave just because the name was changed? (I submit very few if any would leave. I participate because of the people and ideology, not because of the name. So, we probably would lose hardly anybody because of a name change.)
- * How many native americans do you think are attracted to the name "Pilgrim?" (I contend it is quite negative to them. The name is a deterrent for them to even think of going to "Pilgrim House.")
- * How many blacks do you think are attracted to the name "Pilgrim?" (I contend it is mostly negative to them. The name is a deterrent.)
- * Isn't it worth it to at least investigate a name change to improve our image and attract a more diverse group of people? Let's be flexible and innovative. Let's not get stuck in the mud. It seems to me, there is very little downside and a lot more upside to this idea. What do you think?

On the negative side: a name change will require A LOT of effort: bylaws, tax exempt status & legal implications, sign, website, printed material, UUA, and so forth. Plus we have to come up with a good and unique name (Arden Hill Unitarian Universalist Fellowship? [from Bill Rohde who started this discussion]). We also lose the name recognition we have (could be good or bad).

GREAT DECISIONS AT PILGRIM HOUSE

April 1 – Struggles over the melting Arctic

U.S. President Donald Trump left many scratching their heads when it was rumored that he was looking to purchase the large island nation of Greenland from Denmark. While any potential deal seems highly unlikely, the event shows the changing opinion within the U.S. government toward engagement with the Arctic region. Because of climate change, large sheets of arctic ice are melting, exposing vast stores of natural gas and oil. With Russia and China already miles ahead with their Arctic strategies, can the U.S. catch up?

Our speaker will be Andrew Latham:

Professor Latham's primary scholarly interests are in the areas of international relations and political thought. He regularly teaches courses on international security, Chinese foreign policy, regional conflict in the Middle East, regional conflict in the Asia-Pacific, medieval political thought, US foreign policy, and conservative

political theory. His most recent publication is Theorizing Medieval Geopolitics: War and World Order in the Age of the Crusades. He has also recently published a novel about the Third Crusade entitled The Holy Lance.

PH ZOOM & ZOOM OPPORTUNITIES

March 21 – Turnout – Making Minnesota the State That Votes

StarTribune columnist and author Lori Sturdevant will talk about her new book Turnout with Joan Growe. The book is the story of Joan's time as Secretary of State and why Minnesota has such a good voting record.

Note: if you haven't seen this, Mel Aanerud and famed columnist Lori Sturdevant interactive spontaneous 1/2 hour exchange, you can see our own political "Chuck Todd, Meet the Press" personality, Mel, in action on the recording!

March 14 – What Happened to the News?

Daniel Hallin is a Professor at the University of California San Diego/La Jolla. Hallin's research concerns journalism, political communication, and the comparative analysis of media systems.

March 7 – What Happened in the Election and its Aftermath?

Professor David Schultz of Hamline and Saint Thomas Universities in Saint Paul is a regular national commentator and a presenter at Pilgrim House.

The presenter actually discussed the trial of Derrick Chauvin and a little bit on election aftermath.

February 28 – The Decline of American Democracy and the Rule of Law

Professor Austin Sarat is Associate Provost and Associate Dean of the Faculty, William Nelson Cromwell Professor of Jurisprudence & Political Science at Amherst College, Amherst Massachusetts. As part of UUA series on "Our Democracy Uncorrupted" Professor Sarat is a national expert.

February 21 – Creating a future for an Inclusive Democracy

Doctor Sylvester Johnson is the founding Director of the Center for Humanities and professor of religion and culture at Virginia Tech. This is the program that most of us at UUA General Assembly attended. We then unanimously decided that we wanted him to speak at Pilgrim House. This presentation examines structural disparities caused by race, wealth and technology. What do we need to do to transform ourselves to chart a bold future in an inclusive democracy?

February 14 – Freedom for Mother's Day – Reverend Kayla Parker

This program is inspired by a project called Mama's Day Bail out, that helps to bail black mothers and caregivers out of prison for Mother's Day. In the sermon, Kayla will talk about the theological grounding for this work as Unitarian Universalists, and discuss an event that was organized by BLUU (Black Lives of Unitarian Universalists)

February 7 – Can Truth Save Democracy – Use of Science Courts

Professor Ellad (Brad) Tadmor of the University of Minnesota has developed Science Courts as a way to save Democracy – a thing only truth can do. He is a speaker of national fame.

PH was not able to record this program directly but there are links to the professor's talk that was on the Internet. It includes a transcript. The Internet had a talk that was very close to the talk given at PH. See https://youtu.be/T9lVw8Fxj-0.

FUTURE PH PROGRAM IDEAS

The Mar 21 Sunday program saw StarTribune columnist and author Lori Sturdevant talk about her new book with Joan Growe. The book is "Turnout" about Minnesota voter turnout. Mel Aanerud and Lori did a fantastic job Sunday with an opening back and forth discussion and then opened it up for general discussion. Members who were in Arizona and Florida participated too!

This kind of nationwide attendance of a PH Sunday program was never possible before. Virtually everyone in the country now knows how to use Zoom. Even after we begin to meet in person again, we should try to maintain that capability to allow anyone who is out of town, unable to meet in person for various physical reasons, or unable to meet at the designated time, to see the PH programs. I believe it would help everyone keep more closely connected broaden PH reach.

We are beginning to research how PH might, with every program, provide a "Zoom-like" capability to expand reach. If anyone would like to help with research in this area, contact Wayne LeBlanc, who will be collecting information. THANKS!

SIGN UP TO JOIN THE 2021 SCIENCE **COURT JURY**

Remember Professor Ellad (Brad) Tadmor of the University of Minnesota who spoke to us about his Science Courts? – He sent this message to us: Hello,

As you may have heard, the 2021 Science Court case (https://scicourt.umn.edu) is focused on mandatory service and whether or not it has the potential to fight polarization in America. The students in Science Court are hard at work researching mandatory service and polarization, as well as formulating the pro and con arguments for mandatory service that they will present to the Science Court jury at the April trial.

Do you want to help us decide the polarization case? You can sign up at z.umn.edu/scicourt-jury to be considered for the 2021 Science Court jury. Upon signing up, you'll be asked to complete a short survey to help us build a heterogeneous jury. Selected jury members will hear the evidence presented by students and deliberate with fellow jurors to render a verdict. All selected jurors must attend the full day virtual trial on Saturday, April 24 and a virtual deliberation session on Sunday, April 25.

BREATHE; A LETTER TO MY SONS

Each year, the Unitarian Universalist Association chooses a book title to

help build community in our congregations and our movement by giving diverse people a shared experience, shared language, and a basis for deep, meaningful conversations.

In this year's selection, Breathe: A Letter to my Sons, author Imani Perry issues a challenge to society to see Black children as deserving of humanity. She admits fear and frustration for her sons in a society that is increasingly racist and at times seems irredeemable. Perry offers an unfettered expression of love—finding beauty and possibility in life—and she exhorts her children and their peers to find the courage to chart their own paths and find inspiration in Black tradition.
